

## DECLARATION OF PARTNERSHIP





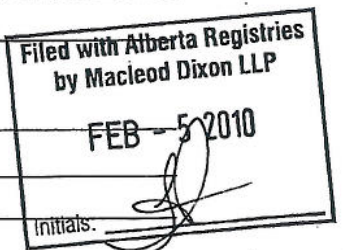
